

**TOWN OF ROME, MAINE**  
**BOARD OF SELECTMEN MEETING MINUTES**  
**February 28, 2022**

Chairman Paul Anderson called the meeting of the Board of Selectmen to order at 6:00PM. Selectman Anderson, DiPietro Jr, and Archer were present. Also present for all or parts of the meeting were, Tammy Lyons, Alice VanDerwerken, Dr. Andrew Cook, Joan Orr, Christie Guite and Carolyn Hurley.

**Pledge of Allegiance**

**Public Comment:** Dr. Cook spoke on the 7 Lake Quality Virtual Meeting schedule for Thursday, March 10, 2020 at 6:30pm. Also noted was that Rome's contribution to the 1<sup>st</sup> Park /KRDA is 4%. (Dr. Cook gave a hand out to the Select Board) The Selectmen spoke on clarification and specific scenarios to Dr. Cook, Ms. Orr and Ms. VanDerwerken on Article 3 - "Shall this municipality authorize the State to issue licenses for the sale of liquor to be consumed on the premises of licensed establishments on days other than Sunday? "

Ms. VanDerwerken questioned why the Budget Committee's Report wasn't in the 2021 Town Report. The Select Board explained that due to timing of going to print and the fact that some information needed to be revised did not allow enough time to add into the 2021 Town Report. It was noted if their report was amended, the Town Office could post their report on the Town's website.

Christie Guite spoke on paving of Ladd Road. The Select Board advised her to gather signatures from residents of Ladd Road for support of her request.
