Pledge of Allegiance:

Public Comment:

Sandy Shute spoke on AARP Grant application. She will apply for AARP Grant and follow up with the Select Board. Also spoke on "Hot Spot" Project.

Christie Guite submitted a petition signed by fellow residents to have Ladd Road paved. She also spoke on the Park & Ride located on Route 27. Her husband has observed many discarded hypodermic needles. The Select Board will contact Maine DOT.

Tax Collector and Treasurer Report Tammy Lyons:

Explained the mileage stipend for the Road Commissioner which is a monthly stipend of \$41.66.

Also requested of the Board to make a motion to correct the CEO salary listed on the Town Report, Article #36, as \$26,800 to the correct amount \$29,625. No change in the total Salaries
